I Guard OrdersI GUARD ORDERS

1. Until further orders the guard for the Battalion will consist of an armed guard furnished by companies A, B, and C. Effective this date the guard will be composed of:-

- 1 Sergeant of the Guard
- 3 Corporals of the Guard
- 17 15 Privates of the Guard
- 1 Driver

2. The details for the guard will be published by this headquarters.

3. Guard Mount: Informal at ^{1815/1800} ~~1530~~ daily in the front of the guard tent. Guard will be formed at ~~1800~~ daily and be instructed by the new Officer of the Day in guard duty until retreat. The formation, inspection and relief of the guard will be as prescribed in FM 26-5, Interior Guard Duty, Appendix I, Paragraphs 3 and 4. The Officer of the Day will form the guard at 0630 at the Guard Tents and relieve them. ₀₇₀₀

4. Uniform: (a) Cotton Khaki Shirt and Trousers, leggins, helmet liner, cartridge bolt, under arms.

(b) All members of the guard will be armed with their individual basic weapon.

5. Reliefs: There will be three reliefs: 2 hours on and 4 hours off.

6. Post: There will be ^{four} five posts as follows:-

Post No. 1, includes line of mess halls, P.X. and Dispensary; Bn. Hq. tents and officers tents.

Post No. 2, includes Bn. Tent. Area.

Post No. 3, includes Motor Pool and B. S. O.

Post No. 4, includes Material Yard.

Post No. 4, includes Ammunition Dump.

7. To insure full coverage of their posts, sentinels will vary their route of walking their post at frequent intervals.

8. Sentinels will remain in the immediate vicinity of the Guard Tents when not on post, unless temporarily relieved by the Sergeant of the Guard.

9. The Sergeant of the Guard and the Corporal on relief will be in the Guard House at all times except when at Mess, latrine or on their guard duties. The Sergeant or Corporal will be in the Guard House at all times. The Corporal of each relief will personally post his relief.

10. Sentinels will be on the alert for fires and unauthorized personnel in Bn. Area. All suspicious persons will be challenged.

11. The company on guard will also furnish the Officer of the Day. The name of the Officer of the Day to go on Duty will be reported verbally to the Bn. Adjutant by 1500 on the day the company has guard.

12. The Officer of the Day will:


- a. Remain and sleep in the S-1 tent when not performing guard duties that require him elsewhere.
- b. Instruct the guard as prescribed in paragraph 2 above.
- c. Receive the reveille and retreat reports from company duty officer at Guard Tent immediately after each formation.
- d. Upon verifying the need the officer of the day will sign all dispatches of vehicles to be used after 1800.

13. Transportation: The company on guard will furnish the Officer of the Day with one jeep to be used during his tour of duty.
