1. All previous Guard Orders are rescinded.
2. While in the present area an armed guard will be furnished by rotation among the lettered companies. This guard will be composed of:-
 - 1 Officer of the Day
 - 1 Sergeant of the Guard
 - 3 Corporals of the Guard
 - 18 Privates of the Guard
3. The formation, inspection and relief of the Guard will be as prescribed by the Bn. C.O. Orders for the Guard will be as stated in FM 26-5 plus such special orders contained in Paragraph 11.
4. The Guard will be rotated between lettered companies by roster as published by this Headquarters. Name of the Officer of the Day will be submitted to the Adjutant by 1500 on the day before he is to be on duty.
5. Guard mount will be informal at 1745 daily in front of the Battalion CP. The new Guard will be formed at 1745 and instructed in guard procedure by the Officer of the Guard until retreat. Tour of duty will be from 1815 to 0800.
6. The Guard will be quartered in their respective company area. The post of the Officer of the Day will be at his company CP.
7. Uniform will be wool OD, combat boots, steel helmet, under arms. Outer garment as prescribed by the Officer of the Day.
8. The old Officer of the Day and the New Officer of the Day will report to the Commanding Officer with the Guard book at 1815 daily.
9. The Guard will consist of 6 one man walking posts as shown on attached sketch.
 - a. Post No. 1-Sentry will patrol counter-clockwise around buildings occupied by H&S Company and Battalion Headquarters.
 - b. Post No. 2-Sentry will patrol counter-clockwise around buildings occupied by "A" Company.
 - c. Post No. 3-Sentry will patrol counter-clockwise around buildings occupied by "B" Company.
 - d. Post No. 4-Sentry will patrol counter-clockwise around buildings occupied by "C" Company.
 - e. Post No. 5-Sentry will patrol one-half of Battalion Motor Pool as indicated on attached sketch.
 - f. Post No. 6-Sentry will patrol one-half of Battalion Motor Pool as indicated on attached sketch.
10. Between the hours of 0800 and 1815 each company will have a one man guard circling its company area for the purpose of preventing civilians from entering or loitering near the company billets or installations. H&S Company will, in addition to the Guard in the H&S Company area, furnish one guard to walk post inside the Battalion Motor Pool area.
11. SPECIAL ORDERS:-
 - a. All guards will prevent civilians from entering or loitering near buildings or installations on their posts.
 - b. Time of challenging will be from 2100 to 0600.
 - c. Passes issued to civilians will not be honored unless countersigned by the Battalion Commander or the Battalion Executive Officer.
 - d. Any civilian apprehended between the hours of 1800 to 0700 will be held and turned over to the Officer of the Day.

e. Post No. 6: (1) Will phone Guard Headquarters every hour between the hours of 2000 and 0600; (2) Will allow no vehicle to leave the Motor Pool between the hours of 1700 to 0800 without a properly signed dispatch.

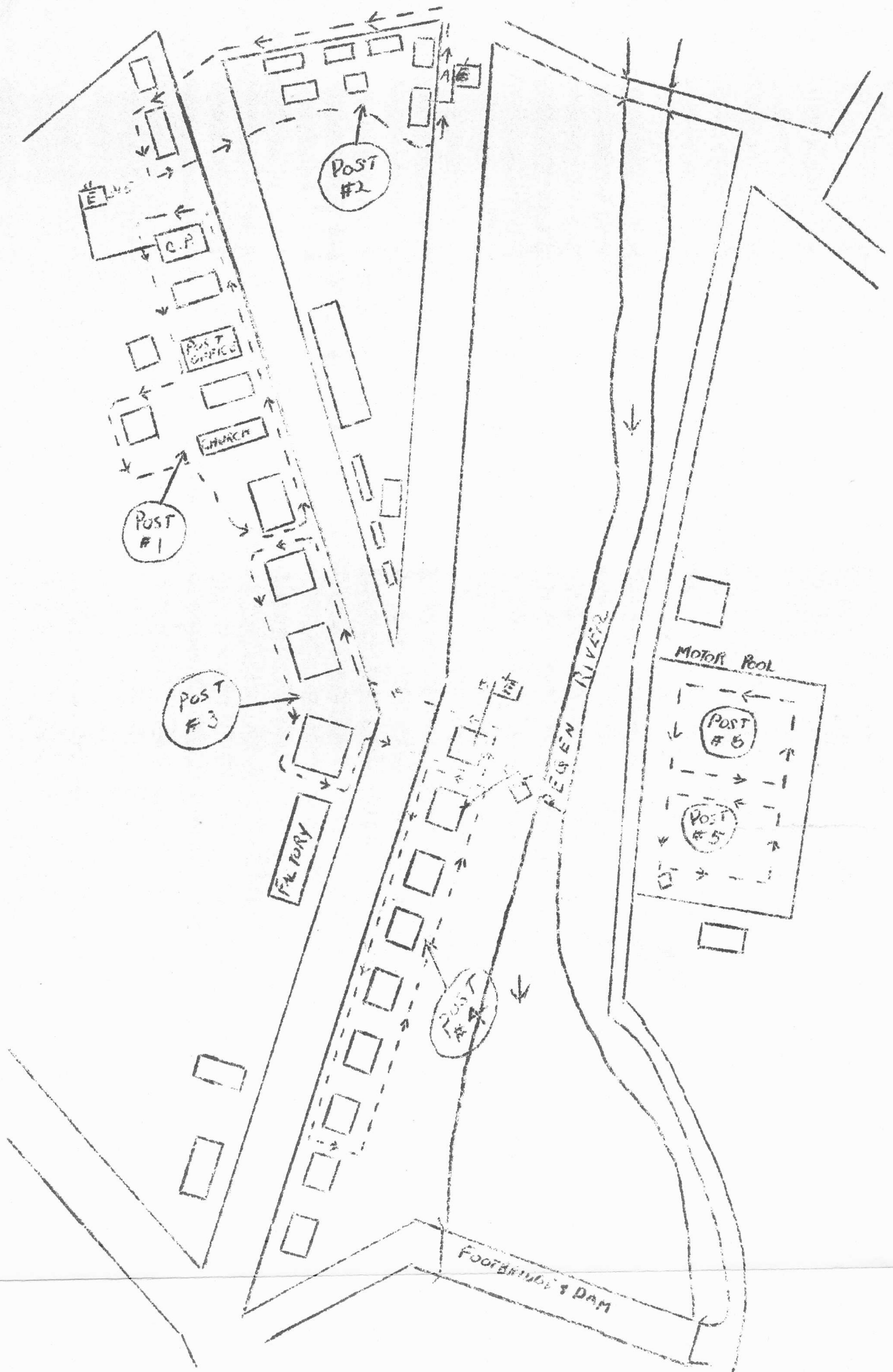
