I. AWARD OF THE PURPLE HEART By direction of the President and authority contained in AR 600-45, 22 September 1943, as amended, The Purple Heart is awarded to the following named Officer and Enlisted Men, United States Army, for wounds received in action against the enemy:

So much of Section II, General Order No. 40, this Headquarters, dated 15 November 1944, as awards the Oak Leaf Cluster to the Purple Heart to Private First Class Bent Smith, 35653858, Infantry, as reads, "wounded on 29 October 1944," is amended to read, "Wounded on 2 October 1944."
