I. AWARD OF THE PURPLE HEART. By direction of the President and authority contained in AR 600-45, 22 September 1943, as amended, The Purple Heart is awarded to the following named Officer and Enlisted Men, United States Army, for wounds received in action against the enemy in France, unless other location indicated:
