SECTION I

1. General Orders No. 6, Headquarters 359th Infantry, May 21, 1942, is rescinded.

SECTION II

1. Pursuant to instructions issued in General Order No. 4 Hq. 90th Infantry Division, Camp Barkeley, Texas, March 27, 1942 and FM 26-5, the following regulations are prescribed for the Interior Guard of the 359th Infantry Regiment in safeguarding the public property and buildings in the regimental area as shown in annex No. 1 to General Order No. 4, Hq., 90th Infantry Division, as amended by letter Hq 90th Division dated June 27, 1942, subject: Guard, Fire, and Police Area.

2. The following duties will be performed by the personnel of the guard in addition to those prescribed by FM 26-5:

Officer of the Day

a. The Officer of the Day will take reveille and retreat reports from the respective battalion and special units duty officers. This report will be taken from a post in front of the main entrance to the regimental recreation hall.

b. The Officer of the Day will perform his regular duties during drill hours in addition to his duties as Officer of the Day.

Commander of the Guard

a. The Commander of the Guard will carefully instruct his guard as to the location of fire alarm boxes and the method of giving the fire alarm.

b. The Commander of the Guard will instruct his guard in all pertinent camp regulations and require that they be complied with.

c. He will instruct his guard that civilians will not be permitted in the regimental area, except on streets and in buildings open to the public, unless they have a written pass issued by the regimental Adjutant. Friends will be permitted to visit enlisted men in the company day rooms, but will not be allowed to enter tents except in the company of an officer.

d. He will not accept prisoners for confinement, but will give instructions that they be sent to the camp stockade accompanied by a written statement covering the prisoner's name, grade, serial number, organization, Article of War violated and a brief description of the offense.

e. He will instruct his guard that they will not arrest civilians, but, if a civilian is guilty of any offense in violation of his special orders, he will be detained and the Provost Marshal notified immediately.

3. The posts of the guard are as follows:

Mounted Patrol No. 1. Consists of a Corporal of the guard and a private of the guard, the latter to drive a quarter ton truck. This patrol to cover the regimental area and all streets included therein.

Post No. 1. Around all buildings and vehicles parked in the 359th Motor Pool.

Mounted Patrol No. 1:

1. This patrol will cover the entire 359th Infantry Regimental area.
2. At least four times every hour it will pass regimental headquarters, the post exchange and the regimental supply warehouse. Also it will circle the entire regimental area and each battalion area four times per hour.
3. It will contact the sentry on Post No. 1 at least four times every hour.
4. It will not follow any set route, but will endeavor to change routes and direction as much as is possible and still uniformly cover the area.
5. To allow no loitering.
6. In case of fire to awaken the occupants of the building, then proceed to the nearest fire alarm box and give the alarm.
7. To allow no government property to be removed from any post without authority from the Commanding Officer, Officer of the Day, or Officer of the Guard.

Post No. 1:

1. My post extends around the buildings and vehicles parked in the 359th Motor Pool.
 2. To allow no vehicles to be removed from the Motor Pool except through the main entrance to the pool.
 3. To allow no one to loiter in the vicinity of the Motor Pool.
 4. To check all vehicles to see that the keys are in the switches.
 5. To allow no one to remove any property from vehicles or the Motor Pool without authority from the Commanding Officer, the Transportation Officer, the Supply Officer or the unit commander of the unit to which the vehicle is assigned.
 6. In case of fire, to notify the dispatch office immediately and to attempt to extinguish the fire.
5. Post No. 1 will be a 24 hour post. Mounted Patrol No. 1 will be on duty from 2000 to 0700 only.
