I. AWARD OF THE BRONZE SERVICE ARROWHEAD. Under the provisions of Section I, Circular 465, War Department, 9 December 44, as amended; letter, Headquarters European Theater of Operations, United States Army, file AG 200.6, Subject: "Individual Service Award of the Bronze Service Arrowhead", 9 May 45, and Circular 35, Headquarters 90th Infantry Division, 27 July 45, Tec 4 Daniel Dennehy, 31 072 606, Med Det, 359th Inf, who was a member of that orgn on 6 Jun 44 is awarded the Bronze Service Arrowhead.

II. AWARD OF THE PURPLE HEART (BRONZE OAK LEAF CLUSTER). Under the provisions of AR 600-45, 22 Sep 43, as amended, and in addition to the Purple Heart previously awarded to him, a Bronze Oak Leaf Cluster is awarded to Pfc Donald V Teegardin, 15 331 057, Med Det, for wounds received in action against the enemy in Germany on 11 Dec 44. Entered military service from Indiana.

III. AWARD OF THE PURPLE HEART. Under the provisions of AR 600-45, 22 Sep 43, as amended, The Purple Heart is awarded to Tec 4 Harry M Brown, 35 708 163, Inf, for wounds received in action against the enemy in France on 14 Jun 44. Entered military service from Indiana.

IV. AWARD OF THE COMBAT INFANTRYMAN BADGE. Under the provisions of WD Circular 408, 17 Oct 44, as amended, the Combat Infantryman Badge is awarded to the following EM retroactive to the dates indicated:
